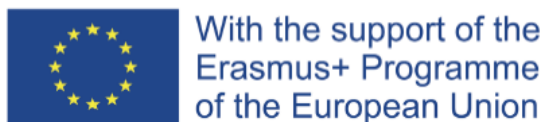

IN MEMORIAM

Wade Jacoby (1964-2020)



It is with deep sadness and a very heavy heart that we received the devastating news of the untimely passing of our dear colleague and friend, Wade Jacoby, on February 29, 2020.

Many of us in the EU studies community came to know Wade over the years as an exceptionally generous, kind, thoughtful, honest, intelligent and decent human being. A brilliant scholar, one of our leading thinkers on European political economy, European integration and transatlantic security, Wade was also a beautiful writer, an engaging speaker, a dedicated mentor, and a gifted teacher. He was truly outstanding in how he lifted everyone up, going out of his way to engage with and to encourage countless young scholars and colleagues over the years. He made our field better by leading with integrity and academic excellence. We can comfort ourselves with the knowledge that he lived his life to the fullest, with grace and compassion.

We all mourned the loss of one of the most valued members of our Executive Committee. We honor Professor Jacoby's life and scholarly contributions during the EUSA Biennial Conference in Miami, FL in May 2022 by renaming the EUSA Best Dissertation Award the Wade Jacoby Best Dissertation Award. In this, Wade's memory can continue to uplift and inspire, as we imagine Wade would have wanted.

Welcome to EUSA 2022! It's nice to have you back and to meet once again. In the time since we last assembled, the global COVID-19 pandemic has affected nearly every aspect of political, social and economic life. We delayed our 2021 meeting out of an abundance of caution but also because US borders were unprecedentedly closed to European visitors. The pandemic is a once-in-a-lifetime event, and we are still grappling to understand its consequences. On the program this year are several exciting panels that present cutting-edge research on some of the unique ways that the pandemic effects the European Union, its institutions, and its 450 million citizens.

Since we last met, Europe has also—once again—seen war on its continent, with Russia's unprovoked assault on Ukraine. The Russian war in Ukraine reverberates across the EU, from governments having critical conversations about gas dependency to everyday citizens taking in Ukrainian refugees. In discussing NATO Enlargement and EU candidacy, the war will no doubt feature as a central part of our discussions at this conference as well, including a special roundtable on the war in Ukraine on Saturday afternoon.

These events and others underscore—more than ever—the importance of assembling our community of European Union scholars. Zoom meetings and webinars sustained the exchange of ideas during the pandemic, but both are insufficient replacement to the spontaneity, serendipity, and smiles that come with in-person conferencing. Among the many lessons of the pandemic, one is the power of community. A professional association is a community, and we are all here to harness the power of that community to have critical dialogues on the EU. As the largest EU Studies Association in the world, it is only fitting that we convene this year around the conference theme: "Recovery and Reconnection: European Integration Against the Tide." To do so, we welcome over 450 participants from almost 200 institutions.

To highlight a few of our program's offerings, we have three lunch time plenary sessions examining the politics of eurocentrism and Europe's revival, and a celebration of the lifetime achievements of Helen Wallace. On Thursday night, Catherine de Vries will offer the Journal of Common Market Studies lecture. Additionally, this year we are offering four morning Cafés – on diversity and inclusion, teaching the EU, research, and getting published. EUSA will provide breakfast to go Friday from 8:15-9:15 am to sustain during these vital conversations.

I am truly grateful for all of the organizations that provided support for the meeting. Here I would like to take a moment to thank the University of Pittsburgh, which supports EUSA on its campus and with generous financial support. **Special thanks go to Markus Thiel and Christine Caly-Sanchez from Florida International University for tireless local support.** We also thank our sponsors: JCMS: the Journal of Common Market Studies, Boston University, Center for European Studies at University of North Carolina at Chapel Hill, European Parliament Liaison Office, **Miami-Florida Jean Monnet European Union Center of Excellence at Florida International University**, University of California Berkeley, European Studies Center at the University of Pittsburgh, University of Wisconsin Madison, and Virginia Tech. A selection of the best papers from the conference will again be published as a special issue of the Journal of European Public Policy in 2023. UNDERGRADUATE RESEARCH CONFERENCE on the EUROPEAN UNION

The European Union Center of California at Scripps College invites faculty across the United States and Canada to encourage their undergraduate students to submit research papers to the annual Undergraduate Research Conference on the European Union.

The annual Undergraduate Research Conference on the European Union is the oldest academic conference in the United States dedicated to undergraduate research on European Union topics. The purpose of the conference is to enhance undergraduate training in and knowledge of the European Union and transatlantic relations, to recognize the excellent work achieved by undergraduates, to foster intercampus cooperation, and to allow students with expertise in different areas to interact with each other as well as with faculty experts.

The conference is usually held the first Thursday and Friday in April at Scripps College in Claremont, California. Applications with an abstract are due in mid-February, and final papers are due by mid-March. There is no fee to register for the conference, and the European Union Center of California covers the cost of students' lodging and meals. Students present their research in a panel format, each panel being composed of three to five students. Each presentation is followed by questions and a discussion moderated by a faculty discussant.

Eight to twelve papers presented at the conference each year are chosen for publication in the open-access Claremont-UC Undergraduate Research Conference Journal. In addition, the EU Center of California and some of its partner institutions often offer awards for the top two papers with summer study tours to Europe.
