KEYNOTE SPEAKER

Amb. Caroline Vicini

Deputy Head

Delegation of the European Union to the United States in Washington D.C.

Prior to joining the Delegation, Ms. Vicini served as Chief of Protocol, with the rank of Ambassador, at the Ministry for Foreign Affairs in Stockholm, Sweden. During her five years in this position, she was the focal point on all issues related to the Vienna Convention for Stockholm's 109 foreign missions, and in charge of all high-level visits to the Swedish government.

From 2008 to 2009, Ms. Vicini worked in Washington, DC, as managing director for the public affairs company, Kreab Gavin Anderson serving Scandinavian corporate clients. In the second half of 2009, she replaced the Deputy Chief of Mission (DCM) at the Swedish Embassy in Dublin.

From 2004-2008, Ms. Vicini was the DCM at the Embassy of Sweden in Washington, DC, a posting that coincided with the construction and inauguration of the new chancery by the Potomac River in Georgetown. During her tenure in Washington, she led the project team that developed the House of Sweden's public diplomacy program.

From 1999 to 2004, Ms. Vicini worked in security policy and military affairs at the Swedish Ministry of Foreign Affairs, first as Head of the Pol-Mil section and thereafter as Deputy Head of the Department of European Security Policy. She handled policy areas including: CBMs, defense material, the initial development of the EU's Common Security and Defense Policy (CSDP), and matters related to the intelligence agencies.

Ms. Vicini's earlier postings include Algiers, Paris, and Rome, where she also worked at the headquarters of the World Food Program. She has a Master's in Business Administration from the School of Economics at Gothenburg University.

Hon. Cándido Creis Estrada

Consul General of Spain in Miami

Cándido Creis is a career diplomat in the Spanish Foreign Office. In 1995, he took up his first assignment as Head of Foreign Policy and Security Area at the Ministry of Foreign Affairs and Cooperation in Madrid. In 1996 he joined the staff of the Royal Household of His Majesty the King as Deputy Director of the Department of Protocol. In 2001 he went on to work at the Permanent Representation of Spain to the European Union in Brussels until 2006. From 2006 to 2009 he served as Counselor at the Embassy of Spain in Tel Aviv. In 2009 he returned to Brussels to the Permanent Representation of Spain to the European Union. In 2010 he was Chief of Staff of the Undersecretary of the Spanish Ministry of Foreign Affairs and Cooperation.

Most recently, Cándido Creis was appointed Chief of Protocol of the Royal Household of His Majesty the King of Spain (2011 – 2014). From December 2014 to July 2015, he served as Vice Commissioner of the Spanish Pavilion of the World Expo –Milano 2015 ("Feeding the Planet, Energy for Life").

Since August 2015, Cándido Creis is the Consul General of Spain in Miami for Florida, Georgia and South Carolina.

Cándido Creis has a Law Degree from the Complutense University of Madrid and a Course of English Law from the University of Kent at Canterbury.

Catalin Ghenea assumed his duty as Consul General of Romania in Miami on December 5th, 2017. Prior to this appointment he was posted as Consul and Consul General in Los Angeles.

I teach various levels of economics courses at the University of Miami for the Department of Economics and International Studies. Since 2005, I have been working, researching, and publishing under the umbrella of the European Union Center of Excellence at the University of Miami as an Associate Editor.

My academic background has allowed me to become an economic researcher and analyst which has help me produce innovative academic work, take part in conferences, and participate in leading TV programs as economic commentator.

My research interests are in the areas of economics with a link to political events and social issues with special reference to the European Union (EU), unemployment, the euro, and the foreign exchange market. On this note, my research has four focuses. First, my research analyzes the evolution of the European political, economic, and monetary integration process. Second, I study the evolution of the euro and its implication for the Eurozone and the EU from a political, economic and social point of view.

Third, my research focuses on the role of the euro in the foreign exchange market vis-à-vis other currencies. Finally, my work assesses the implication of the European integration development in other countries mainly in Latin America where the integration process has stalled due to internal mistrust and external lack of support.

Robert Morgus is a senior policy analyst with New America's Cybersecurity Initiative and International Security program and the deputy director of the FIU-New America C2B Partnership. His current research focuses on mechanisms to counter the spread of offensive cyber capability, cybersecurity and international governance, and Russian internet doctrine. In the past, he has authored reports on international cybersecurity norms, internet governance, cybersecurity insurance, amongst others. Morgus has spoken about cybersecurity at a number of international forums including NATO's CyCon, the Global Conference on Cyberspace at The Hague, and Cy Fy 2015 in New Delhi, India. His research has been published and recognized by the *New York Times, Slate*, the IEEE, peer-reviewed academic journals, and numerous other national and international media outlets. Morgus serves as a member of the Research Advisory Network for the Global Commission on Internet Governance, as well as the Global Forum on Cyber Expertise, and has served as an expert advisor for the World Economic Forum.

Before joining New America, Morgus provided research and logistical assistance for a variety of organizations ranging from sustainable development firms to political action committees. Morgus received his BA with honors in diplomacy and world affairs from Occidental College in Los Angeles in 2013 where he focused on international security. While at Occidental, he was the recipient of the Young Fund Student Grant to conduct research on ethno-nationalism in Bosnia and Herzegovina, Croatia, and Serbia. His current project focuses on focuses on the promotion of rights policies through civil society based on the EU's Fundamental Rights Charter/Agency (forthcoming 2016).

He regularly teaches CPO 3103 Comparative (Western) European Politics, CPO 3104 EU Politics, INR 3214 International Relations of Europe, INR 3502 International Organizations and the European Studies Colloquium, as well as graduate courses on European/EU Politics, International Organization and Research Design in IR. In addition, Dr. Thiel is a director of the Miami Florida Jean Monnet Center of Excellence and of GSIPA's European & Eurasian Studies Initiative.

He graduated magna cum laude from Harvard Law School, where he served as a member of the Harvard Journal of Law and Technology and the Harvard Human Rights Journal, and as a teaching assistant in Harvard College. After law school, Professor Travis clerked for the United States District Court in Los Angeles, California. Professor Travis has published articles on copyright, trademark, and antitrust law in the Berkeley Technology Law Journal, Hofstra Law Review, the Journal of the Copyright Society of the USA, Notre Dame Law Review, Pepperdine Law Review, University of Miami Law Review, Vanderbilt Journal of Entertainment and Technology Law, Virginia Journal of Law and Technology, and Yale Journal of Law and Technology. He has also published works on antitrust law, telecommunications law, and net neutrality in American University Law Review, Hofstra Law Review, and Santa Clara Law Review.
